\*Renter is responsible to make sure all garbage is placed in garbage cans.

\*Renter is responsible for damages while occupying that portion of the gymnasium area.

\*No smoking, alcohol or firearms are permitted on the property of North Union Township Recreation Center.

\*Enter and exit through the main entrance ONLY.

\*Renter and Guest must follow any rules that are posted at the recreation center.

\*Children under the age of 14 must always have adult supervision.

\*Appropriate shirts and sneakers must be worn in gymnasium area.

\*The Township & Center is not responsible for anything lost, stolen or damaged.

\*Please be aware that the North Union Township Recreation Center Employees have the right to enter the gymnasium area to verify that all guests are abiding the agreement and have the authority to enforce recreation center rules.

### NORTH UNION TOWNSHIP/NORTH UNION TOWNSHIP RECREATION CENTER WAIVER AND RELEASE OF ALL CLAIMS:
