- *No smoking, alcohol or firearms are permitted on the property of North Union Township Recreation Center.
- *Children under the age of 16 must always have adult supervision.
- *Must follow any rules that are posted at the recreation center.
- *The Township & Center is not responsible for anything lost, stolen or damaged.
- *Please be aware that the North Union Township Recreation Center Employees have the right to enter the gymnasium area to verify that all guests are abiding the rental agreement and have the authority to enforce recreation center rules.
